- You must first create a Tourist Development Tax (TDT) account online for the short term rental listed on this application. Please visit [www.pbctax.com/tdt](http://www.pbctax.com/tdt) to create an account.
- This STR-LBTR cannot be transferred. It is only valid for the short term rental and TDT account number listed on this application.
- If you host more than one short term rental, you must have a Tourist Development Tax account and STR-LBTR for each property.
- The short term rental local business tax receipt (STR-LBTR) does not require zoning approval.
- You must renew this STR-LBTR annually by Sep. 30 to continue offering the property listed below for short term rental.
