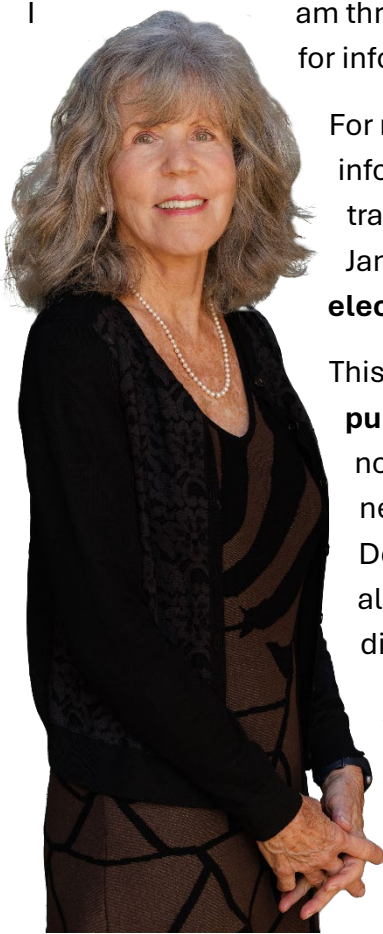

For the past five years, Hampton Peterson has been leading our office's Legal, Field Services, and Facilities departments.

The Legal department handles everything from contracts and litigation to bankruptcy proceedings filed by individuals and businesses, public record requests, and collections support for the organization, and whose team also processes tax deed applications for past due property tax deed auctions.

"What I enjoy most about my job is the variety of things I have to deal with each day," says Hampton, who also fields any day-to-day legal questions that may arise.

Our Field Services team pursues payments from taxpayers who have unpaid fees, handles charges for delinquent accounts, and identifies businesses that do not have required Local Business Tax Receipts.

The Facilities team deals with all sorts of issues, primarily in our Palm Beach Gardens, Greenacres and Westlake offices. They oversee such tasks as getting bids from contractors and making sure the HVAC systems are working, as well as day-to-day maintenance of our buildings.

Surrender Plate, Don't Wait!

Did you know that failing to surrender a valid Florida license plate that is no longer in use could lead to unexpected consequences, including the possible suspension of your driver's license?

Why Surrender Your Plate?

When a license plate is no longer attached to a registered vehicle, it must be properly surrendered for the following reasons:

- **Avoid License Suspension:** The most immediate concern is preventing a driver license suspension that can be triggered by having an unused, but still valid, license plate on file.
- **Prevent Fraud and Misuse:** An improperly surrendered plate can be vulnerable to fraud or misuse. If the plate is used in a fraudulent or illegal manner, it will always be connected back to ***your name***.
- **Peace of Mind:** Properly surrendering your plate severs the legal connection to you, giving you assurance that you won't be held responsible for its future use.

How to Surrender Your License Plate

It's a simple process that can save you significant trouble down the road. You can surrender your valid Florida license plate in one of two ways:

TCO Gives Back

Every year we participate in the Clerk of the Circuit Court and Comptroller's, holiday Money Drop event.
